This training provides interpreters with essential knowledge of services, norms, and vocabulary across various healthcare settings, including hospitals, outpatient clinics, and long-term care facilities. Participants will learn to interpret effectively in these environments and gain key insights into care transition planning, helping facilitate clear communication during the transfer of care between settings. By the end of the course, participants will be better equipped to support healthcare workers, patients, and clients in these critical moments.

## **Learning Objectives:**

Jena Adams is Senior Vice President at the Center for Health Impact. She has worked in public health for more than three decades, focused on increasing health and language equity through community-government-academic partnerships, health workforce development, impacting public policy, and informing research to improve access to quality healthcare and education. Jena authored the original Care Transitions Education Project (CTEP) curriculum\* updated and adapted for this training session and has facilitated professional development training for hundreds of Community Health Workers, Interpreters, medical students, social workers, nurses, care coordinators and other health care workers. Jena is a Spanish-speaker and has a master's degree in public health from the University of Michigan.

\* Care Transitions Education Project is a curriculum of the Massachusetts Senior Care Foundation and Western Massachusetts Nursing Collaborative and was originally funded in part by the Partners Investing in Nursing's future, a collaboration of the Robert Wood Johnson and Northwest Health Foundations (2011-2014).
